Please read this carefully before signing. When signed, this document releases Broombusters Invasive Plant Society and related parties from all legal responsibility for any injury, damage or loss that may occur in connection with your participation in this activity and group.

I, the undersigned participant (please print legibly) _____
recognize that the Broombusters Invasive Plant Society (“Broombusters”) is a volunteer organization whose purpose is: *Cutting, stacking, and removing Scotch broom/gorse on public and private property.*

I further understand and acknowledge that my participation in Broombusters is conducted at my own risk. I understand that participation with Broombusters involves certain risks, all of which are assumed by the undersigned. The risks include, but are not limited to, traffic hazards, injuries from tools, tripping and falling; injuries from branches, thorns, broken glass, needles; wildlife encounters, health hazards of natural plant and animal life, ticks, and other environmental factors. I acknowledge that the risks associated with my participation include the risks of physical injury, illness, loss of life and property damage and I voluntarily assume these risks.

I also understand and acknowledge that my risk in participating in Broombusters is relative to my own state of fitness and my physical, mental and emotional health, as well as the awareness and care that I possess and use. I understand and acknowledge that the officers, organizers and fellow Broombusters are neither trained nor expert in any form of medical assistance, including first aid and CPR.

I hereby hold harmless, indemnify, and release Broombusters, its directors, officers, members, organizers, leaders, volunteers, agents, representatives and all others from responsibility or liability for any losses, prejudice, injury or loss of life that may occur while I am participating, or arising out of or connected with my participation with Broombusters, including those caused by negligent acts and/or omissions of any of the above mentioned individuals or entities, or others acting on their behalf. To that effect, I hereby expressly waive all my rights, recourse, claims or causes of action, (and those of my representative in the event of my death), that I may have against Broombusters, its directors, officers, members, organizers, leaders, volunteers, agents, representatives, and all others in respect of any such losses, prejudice, injury or death.

For myself, my heirs, executors, administrators, or anyone else who may claim on my behalf, agree not to sue, and waive, release and discharge, to the full extent permissible by law all those individuals, societies, organizations, governments, ministries, land owners and provinces, and any of their members or employees or agents, or anyone acting on their behalf, for any and all claims or liability for personal injury, death, damage to property or loss of any kind whatever nature or kind or however cause, whether arising by reason of negligence of anyone – employees, agents or anyone acting on their behalf, or otherwise.
